### Drought Conditions Improve

Drought conditions in the Auburn area improved by one level from extreme to severe as of July 2011 according to the U.S. Drought Monitor. Drought conditions across the State of Alabama also showed significant improvement during the month of July, with no areas of exceptional drought, the most intense drought category, left in the state. The water level in Lake Ogletree was at 483.4 feet as of July 18, which is roughly equivalent to water levels at this time last year. With Lee County still classified as in severe drought, voluntary water restrictions enacted by the Water Works Board in June remain in effect. Watering for all addresses should be restricted to between the hours of 8:00 p.m. and 8:00 a.m. Customers with even numbered addresses should water on Mondays, Wednesdays and Fridays. Customers with odd numbered addresses should water on Tuesdays, Thursdays and Saturdays. There should be no outdoor watering on Sundays. Voluntary water restrictions will remain in effect until further notice.

### Routes To Change for Trash, Recycling and Debris Pickup

Beginning August 1, 2011, approximately 8,500 Auburn households were affected by the trash pickup routing change implemented by the City of Auburn Environmental Services Department.

The new routes, developed jointly by collaborative efforts between the City's IT Department – GIS Division and the Environmental Services Department, allows collection crews to better serve Auburn's citizens. A similar route study was done by the IT Department – GIS Division and the Public Safety Department – Fire Division in 2007 to ensure that Fire vehicles arrived at emergency calls as quickly and effectively as possible.

Affected customers should have received a notice delivered by City employees. To find out if your collection day was affected by the garbage routing change, visit [www.auburnalabama.org/maps](http://www.auburnalabama.org/maps) and view the Public Services Interactive Map. The Public Services Map allows users to locate any City address and not only find out which day the garbage is collected but also which school zone, voting location, voting ward, fire zone, and City Council member is associated with that address.

## 2011 Citizens Planning Academy

## City Council Passes Urban Chicken Ordinance

Auburn residents are able to keep and maintain chickens under a new urban chicken ordinance established by the Auburn City Council. The move comes in response to citizen requests. The City of Auburn Planning Department will issue permits to Auburn citizens wishing to keep backyard chickens.



In September 2010, the Auburn Planning Department was asked to research residential urban chicken keeping in the City of Auburn. Through this research, it was found that residential urban chicken keeping was a national trend in many cities as a result of rising food costs and easy access to fresh organic eggs. Many communities around the country have added regulations regarding chicken keeping to their codes and ordinances. At the June 9, 2011 Planning Commission meeting, the commission unanimously recommended approval of a zoning ordinance text amendment designed to allow the keeping of chickens on residential lots in the City of Auburn. Due to the prohibition of fowl being kept and maintained inside the stock district in Section 4-2 of the City Code, the City Council amended the code to allow urban chicken keeping in the stock district. All regulatory provisions for keeping chickens will be outlined in the zoning ordinance.

The urban chicken-keeping ordinance allows Auburn residents to keep backyard chickens upon applying for and receiving a permit from the Planning Department. In order to be issued a permit, a resident must meet the following conditions:

- The minimum lot size of the property is 10,000 square feet
- The principal use of the property is a single family dwelling
- The number of chickens does not exceed:
  - Four (4) on lots 10,000 square feet to 19,999 square feet
  - Six (6) on lots 20,000 square feet or greater
- The chickens are kept in an enclosure or fenced area such as a henhouse, chicken coop, chicken tractor, etc. at all times
- The chicken enclosure or fenced area is a minimum of six (6) square feet per chicken
- The chickens are not kept in any location on the property other than in the backyard (the rear yard of the principal structure)
- The covered enclosure or fenced area is a minimum of 10 feet to any property line of an adjacent property and 30 feet from neighboring dwellings, church, school, or place of business
- The enclosures are kept in a clean, dry, odor-free, neat, and sanitary condition at all times
- The chicken owner takes necessary action to reduce the attraction of predators and rodents and the potential infestation of insects and parasites

Roosters and the slaughtering of chickens are strictly prohibited inside of the stock district and outside of the stock district unless a lot is zoned Rural (R) and is larger than 3 acres.

Applicants must pay a \$40 permit fee and will need to bring a drawing of their parcel showing the relative location of the residence and chicken enclosure, the size in square feet of the enclosure, et cetera. ## Final Stages of FEMA Map Modernization Project

The Federal Emergency Management Administration (FEMA) Flood Insurance Rate Map Modernization Project is in its final stages. The City of Auburn has received final determination status from FEMA and has until November 2, 2011 to update its flood ordinance and adopt maps through resolution of the City Council. The City Council is scheduled to consider the resolution sometime in late summer. Upon its approval, federally backed mortgage holders will use the latest and most improved mapping to determine insurance rates for affected properties. The mapping is currently being utilized by the City for all construction and development permitting.

### What is good about the nationwide map modernization for Auburn?

A City of Auburn partnership with the Alabama Office of Water Resources and FEMA was established to acquire higher quality data through more detailed studies outside the scope of federal grant requirements for the nationwide project. Initial 1981 flood mapping only provided base flood elevations (BFE) for our main creeks with no elevation data on the City's numerous tributaries. As a result of this 6-year project, Auburn now has BFEs on all creeks and tributaries in its growth area.

New mapping utilizes the latest in Auburn's aerial imagery and digital topography to determine changes in the natural environment since the initial 1981 community flood mapping. Annexation of county lands, development and increased runoff are factored into the revised flood mapping for the City and its growth area to provide improved mapping for floodplain management and future planning.

The revised maps more accurately identify flood risk areas for both existing and potential home buyers. Reviewing the revised flood maps before they become effective on November 2, 2011 is crucial for both the property owner and the buyer as they may receive reduced insurance rates if their insurance policy goes into effect before the November deadline. Potential home owners need to be aware of added expenses associated with federal-backed mortgage requirements of flood insurance.

### What is new with the modern floodplain maps?

- New Terminology: 100 year and 500 year floods are referred to as meeting or exceeding 1% and 0.2% chance of flood in any given year, respectively.
- The 2011 flood maps no longer refer to the flood hazard area as 100 year (A zone), 500 year (B zone), or minimal flooding (C zone). Areas without base flood elevations (BFEs) are still known as A zones while areas with BFEs are known as AE zones. The new maps also identify areas with .2% chance of flooding as X zones.
