

Labor Day holiday schedules

Most City facilities will be closed on Monday, Sept. 7, in observance of Labor Day. Public Safety services including police, fire and communications will remain on their regular schedules. Garbage, trash and recycling collection will be delayed by one day during the week of Sept. 7-11 as listed below:

Monday, Sept. 7 Holiday
Tuesday, Sept. 8 Monday's Route
Wednesday, Sept. 9 Tuesday's Route

Thursday, Sept. 10 Wednesday's Route Friday, Sept. 11 Thursday's Route

The Auburn Public Library's book drops will remain open, and the online collection of e-books, e-audiobooks and digital magazines is always available.

All Parks and Recreation facilities will be closed on Sept. 7 with the exception of Samford Pool and the Yarbrough Tennis Center. Samford Pool will be open 6 a.m.-6 p.m., and this will be the last day the pool is open for the season. The Yarbrough Tennis Center will be open 8 a.m.-noon. All City of Auburn parks, playgrounds and cemeteries will be open sun up to sundown throughout the holiday weekend.

Campaign sign reminders

Here in Auburn, we have certain regulations for signage within city limits. Some of those rules apply to yard signs, including those for political campaigns. Here are a few reminders you can follow to help keep Auburn beautiful:

- Political signs should only be placed out within 30 days before the election. The upcoming election date is Nov. 3, 2020, which means that signs may be placed out beginning Oct. 4, 2020.
- Signs should be no more than 32 square feet.
- All signs must be on private property and cannot be placed on City right of ways, utility poles or traffic signs. In most neighborhoods, the right of way is typically between the water meter and the road. Signs placed in the right of way will be removed.
- Signs for all candidates must be removed within seven days of the election.

Renting your home

Thinking of renting or leasing your home for an Auburn University sporting event or another occasion? Whether you're considering using an online company or doing it yourself, there are some things you should know:

- Renting or leasing your single-family home for less than six continuous months is considered a shortterm rental and may constitute a use violation or an unrelated occupancy violation in accordance with the City of Auburn's Zoning Ordinance. If you are considering renting or leasing your single-family residence for a weekend or any other short-term rental period, please contact the City's Planning Department at 334-501-3040 or webplanning@ auburnalabama.org to find out if the property is zoned to allow short term rentals.
- Renting or leasing your home, condo or apartment for less than six continuous months in an approved zone requires collection and remittance of State, County and City lodging taxes and City license fees
- Renting or leasing your primary home could negatively affect your homestead exemption status with Lee County.

Board Vacancies

One vacancy on the Lee County Youth Development Center Board of Directors and two vacancies on the Industrial Development Board will be announced at the Aug. 18 City Council meeting and filled at the Sept. 15 meeting. Veggie Trails garden additions

While construction on the new Veggie Trails garden at our Boykin Community Center wrapped up earlier this spring, several new features have been added to the ever-growing project. In July, our Public Works crews designed and constructed a downspout rock and herb garden with annual herbs to compliment the vegetables growing nearby. A water gage has been added that allows staff to monitor how much water remains in the rain-collecting cisterns. They've also installed a produce scale for the tenants to measure how much produce they collect each day.

Tenants at the Boykin Community Center—including Auburn Day Care Centers, Joyland Child Development Center, the Boys and Girls Club and the Auburn Senior Center—each have designated raised-bed gardens that they tend. These gardens are filled with tomatoes, squash, eggplant, bell peppers and more. So far this summer, the gardens have yielded more than 200 pounds of produce. Constructed inhouse by our Publics Work crews, the gardens have proven to be a great teaching tool and resource for the tenants at the community center.







Reducing the spread of invasive trees

You're invited to play a part in stopping the spread of invasive tree species in our community by chopping them down. To foster awareness about how invasive species harm the environment and economy, we've partnered with the Alabama Cooperative Extension System and the Alabama Invasive Plan Council to provide free, native trees for property owners who remove invasive tree species.

Why should we remove invasive plants?

Invasives are non-native plants that cause economic or environmental harm. They compete with native species, often degrading wildlife habitats as they eliminate sources of food and shelter. According to the U.S. Forest Service, invasive plants have contributed to the decline of 42% of the United States' endangered and threatened species. They also cost billions of dollars every year in the U.S., negatively affecting property values, agricultural productivity, outdoor recreation and infrastructure. Invasive plants spread rapidly through massive quantities of seed, aggressive roots or animals. For that reason, it takes a community effort to stop their spread.

How can I participate?

Property owners in the City of Auburn can apply to receive up to five native trees for each invasive tree they remove. The following non-native invasive tree species will be included in the exchange:


- Callery pear
- Chinaberry
- Golden Raintree
- Mimosa
- Popcorn tree
- Princess tree
- Privet (2" caliper or greater)
- Sawtooth oak
- Tree of Heaven
- Chinese elm

Once you apply, our urban forester will review your application to determine eligibility. If your application is approved, you'll be asked to submit a photo of the cut down trees. Replacement trees will include crabapples, hawthorns, black tupelos and cherrybark oaks. Trees will be distributed on a first-come, first-serve basis.

Applications will be accepted through Oct. 30 at 4 p.m. Complete guidelines, information on how to identify invasive trees and an application can be found at auburnalabama.org/invasive-species.
